Agenda: (**T.Strong/Dell**) Motion to approve the agenda. Unanimously approved.

(Twiss/Dell) Motion to approve the minutes of August 7, 2007. Unanimously approved.

(**Lewis/L.Strong**) Motion to approve the August 2007 Bill Package totaling \$11,802.84 including the removal of the bill for Ford, Kriekard PC of \$241.60 to be voted as a separate item. Roll call vote: Ayes – Lewis, T.Strong and L. Strong; Nays – Dell, Twiss and Rogers. Motion failed 3 to 3.

(**L.Strong/Twiss**) Motion to approve the August 2007 Bill Package totaling \$12,044.44. Roll call vote: Ayes – Dell, L.Strong, T.Strong, Twiss and Rogers; Nays – Lewis. Motion carried 5 to 1.

(**T.Strong/Twiss**) Motion to approve the July 2007 Treasurer's Report as presented: Major Streets = \$163,035.45; Local Streets = \$15,020.12; General Fund = \$76,001.88; Water Fund = \$34,652.53, Perpetual Care Fund = \$11,406.63; Totals = \$300,116.61. Roll Call Vote: Unanimously approved (6-0).
